The Possibilities Are Endless



The possibilities are endless with a Home Equity Line of Credit (HELOC) from Princeton FCU. You can **borrow as much or as little as you need, whenever you need it**, similar to a credit card.

Many people believe a HELOC can only be used to make home improvements. This is far from the truth. You can use the equity within your home to pay for **education**, a **wedding**, **home improvement** – really *anything* you need extra cash for!

Our HELOC features an introductory rate of **2.99% APR*** for the first 12 months, a 5-year draw period, 24/7 accessibility via Internet Banking, and courtesy checks.

*APR = Annual Percentage Rate. 2.99% Introductory APR is fixed for the first 12 months of the loan. Once the introductory rate expires, the APR may vary. The floor rate is 4%. Your normal APR is based on an index, Prime Rate plus or minus a margin determined at account opening. Prime rate as of 3/1/2014 is 3.25%. Minimum credit limit is \$10K. If refinancing an existing line, you must increase the new line by at least \$10K.
